SUMMARY: The document below is the copy on the patent rolls of the Queen's licence dated 2 December 1591 authorizing Oxford to alienate the 'manors of Castle Hedingham and Gosfield' to Lord Burghley and Oxford's daughters Elizabeth, Bridget and Susan Vere. For the earlier fine in the Court of Common Pleas dated 25 November 1591 by which Oxford transferred title to Castle Hedingham to Lord Burghley and his heirs, see TNA CP 25/2/135/1723/33/34ELIZIMICH, item 74. For the pardon of alienation dated 27 January 1592 by which the Queen pardoned Lord Burghley for his purchase of Castle Hedingham via the fine of 25 November 1591 with having obtained prior licence from the Queen, see TNA C 66/1387, mm. 18-19. Licence of alienation for William, Lord Burghley & others

The Queen to all to whom etc., greeting. Know ye that we of our especial grace have granted & given licence, and for us, our heirs & successors, by how much is in us by these presents do grant & give licence to our dearest cousin Edward, Earl of Oxford, Great Chamberlain of England, that he might be able to give & grant, alienate or acknowledge by fine or by recovery in our court before our justices of the Common Pleas or by any other manner whatsoever at the pleasure of himself, the Earl, to our wellbeloved & faithful counsellor, William Cecil, Knight of the Right Honourable Order of the Garter, Lord Burghley, our Great Treasurer of England, and to our beloved & faithful Elizabeth Vere, Bridget Vere & Susan Vere, the manors of Castle Hedingham & Gosfield with the appurtenances and two hundred messuages, two hundred cottages, one hundred tofts, ten mills, forty dovecots, two hundred gardens, two hundred orchards, three thousand acres of land, one thousand acres of meadow, four thousand acres of pasture, one thousand acres of woods, four thousand acres of furze & heath, two hundred acres of moor, one thousand acres of fresh marsh, free fishery, free warren, common of pasture for all beasts, & ten pounds rent with the appurtenances in Castle Hedingham, Sible Hedingham, Gosfield, Great Yeldham, Little Yeldham, Finchingfield, Toppesfield, Tilbury juxta Clare, Stambourne, Pebmarsh, Foxearth, Hempstead, Bulmer, Great Maplestead, Little Maplestead, Halstead, Gestingthorpe, Belchamp Walter, Belchamp Otten, Belchamp St. Paul, Ridgewell, Sturmer, Havenell, Steeple Bumpstead, & Helions Bumpstead, and also the rectories & chapels of Castle Hedingham & Gosfield with the appurtenances, and all & all manner tithes, portions, pensions, oblations, mortuaries, & obventions whatsoever coming, growing or renewing of & in the parishes of Castle Hedingham, Gosfield, Sible Hedingham, Great Yeldham, Little Yeldham, Finchingfield, Toppesfield, Tilbury juxta Clare, Stambourne, Pebmarsh, Foxearth, Hempstead, Bulmer, Great Maplestead, Little Maplestead, Halstead, Gestingthorpe, Belchamp Walter, Belchamp Otten, Belchamp St. Paul, Ridgewell, Sturmer, Havenell, Steeple Bumpstead & Helions Bumpstead, and also knights' fees, wards, marriages, reliefs, goods & chattels of felons & fugitives, escheats, fairs, markets, tolls, liberties & franchises with the appurtenances, and views of frankpledge & whatever to view of frankpledge belongs with the appurtenances in Castle Hedingham, Sible Hedingham, Gosfield, Great Yeldham & Little Yeldham, and also the advowsons of the vicarages of the churches of Castle Hedingham & Gosfield in our county of Essex, which are held of us in chief, as it is said;

To have & to hold to the same William, Elizabeth, Bridget & Susan & their heirs & assigns forever of us, our heirs & successors, by the services owed therefore, & of right customary;

And by the tenor of these presents we have similarly given, and for us, our heirs & successors aforesaid, we do give special licence to the same William, Elizabeth, Bridget & Susan that they might be able to receive from the forenamed Earl & hold to themselves and to their heirs & assigns forever of us, our heirs & successors, by the foresaid services, as is aforesaid, the foresaid manors, messuages, lands, tenements, rents, and the rest of all & singular the premises above expressed & specified with the appurtenances;

Not willing that the foresaid Earl or his heirs, or the forenamed William, Elizabeth, Bridget & Susan or their heirs by reason of the premises by us, our heirs or successors, or by our justices, escheators, sheriffs, bailiffs or other officers or ministers or [+those] of our said heirs or successors whatsoever might be troubled therefore, molested, interfered with, vexed in anything or oppressed, nor any of them might be troubled, molested, interfered with, vexed in anything or oppressed. In [+testimony] of which thing etc. Witness the Queen at Westminster on the second day of December.
