SUMMARY: The document below is the fine of 20 January 1577 by which clear title to the manor of Battles Hall in Essex passed from Oxford to his friend and kinsman, Charles Arundel, and was returned to Oxford by Arundel. Under the Act of Parliament of 23 January 1552 under which the 16th Earl's lands were restored to him after Somerset's fraud and extortion, the 16th Earl's brother Aubrey Vere had been given a life estate in Battles Hall (see WARD 8/13 and HL/PO/PB/1/1551/5E6n35). By the 16th Earl's indenture of 2 June 1562, the reversionary interest in Battles Hall came to Oxford and his heirs (see PRO C 54/626). It seems likely that Oxford's uncle Aubrey Vere had died by 1577, and that the fine was a means of regularizing Oxford's title to the property. Proclamation of the fine was made sixteen times, beginning on 5 February 1577 and ending on 28 November 1577. For Oxford's later sale of the manor of Battles Hall to John Byrd by a fine of 18 April 1580, see CP 25/2/131/1677/22ELIZIEASTER, Item 9).

This is the final agreement made in the court of the Lady Queen at Westminster on the octave of Hilary in the year of the reigns of Elizabeth, by the grace of God Queen of England, France & Ireland, Defender of the Faith, etc. from the Conquest the nineteenth [=20 January 1577], before James Dyer, Richard Harper, Roger Manwood & Robert Monson, justices, & others faithful to the Lady Queen then there present, between Charles Arundel, esquire, querent, and Edward, Earl of Oxenford, deforciant, of the manor of Battishall alias Battles Hall with the appurtenances, and of two messuages, two cottages, six tofts, six gardens, six orchards, three hundred acres of arable land, forty acres of meadow, one hundred acres of pasture, forty acres of wood, three hundred acres of furze & heath, ten pounds of rent & common of pasture with the appurtenances in Stapleford Abbots;

Whereof a plea of covenant was summoned between them in the same court, namely that the foresaid Earl has acknowledged the foresaid manor, tenements, rents & common of pasture with the appurtenances to be the right of himself, Charles, as those which the same Charles has of the gift of the foresaid Earl, and he has remised & quit-claimed them from himself & his heirs to the foresaid Charles & his heirs forever;

And besides the same Earl has granted for himself & his heirs that they will warrant to the foresaid Charles & his heirs the foresaid manor, tenements, rents & common of pasture with the appurtenances against the foresaid Earl & his heirs forever;

And for this acknowledgement, remission, quit-claim, warrant, fine & agreement the same Charles has granted to the foresaid Earl the foresaid manor, tenements, rents & common of pasture with the appurtenances, and has restored them to him in the same court, to have & to hold to the same Earl & his heirs of the chief lords of that fee by the services which appertain to the foresaid manor, tenements, rents & common of pasture forever.

The sixteenth proclamation on the twenty-eighth day of November in the same term.
