SUMMARY: The document below is the fine in the Court of Common Pleas dated 27 October 1581 by which clear title to the manor of Earls Fee passed from Oxford to Humphrey Drywood and Robert Drywood for £180. For the recognizance for £500 entered into by Oxford on 19 March 1581 in connection with this transaction, see TNA C 54/1118, Part 22.

The Act of Parliament of 22 January 1552 which restored the 16th Earl's lands to him after Somerset's extortion allocated a life estate in the manor of Earls Fee to Oxford's uncle, Aubrey de Vere (see TNA WARD 8/13 and HL/PO/PB/1/1551/5E6n35). For the will of Aubrey de Vere, dated 18 January 1580, see ERO D/AMR 3/281.

Humphrey and Robert Drywood may have been related to Lord Burghley's servant, Bernard Dewhurst. For the latter's will, which mentions 'my son-in-law, Mr Drywood', see TNA PROB 11/89, f. 54.

This is the final agreement made in the court of the Lady Queen at Westminster one month from Michaelmas in the year of the reigns of Elizabeth, by the grace of God Queen of England, France, & Ireland, Defender of the Faith, etc. from the Conquest the twenty-third [=27 October 1581], before James Dyer, Thomas Meade, Francis Wyndham & William Periam, justices, & others faithful to the Lady Queen then there present, between Humphrey Drywood & Robert Drywood, querents, and Edward, Earl of Oxenford, deforciant, of the manor of Earls Fee with the appurtenances and of one messuage, one cottage, one toft, one garden, forty & four acres of arable land, & one hundred & twenty acres of salt-marsh with the appurtenances in Buryes Gifford alias Bowers Gifford;

Whereof a plea of covenant was summoned between them in the same court, namely that the foresaid Earl has acknowledged the foresaid manor & tenements with the appurtenances to be the right of himself, Humphrey, as those which the same Humphrey & Robert have of the gift of the foresaid Earl, and he has remised & quit-claimed them from himself & his heirs to the foresaid Humphrey & Robert, & the heirs of himself, Humphrey, forever;

And besides the same Earl has granted for himself & his heirs that they will warrant to the foresaid Humphrey & Robert & the heir of himself, Humphrey, the foresaid manor & tenements with the appurtenances against the foresaid Earl & his heirs and against the heirs of John, late Earl of Oxenford, deceased, father of himself, the Earl, forever;

And for this acknowledgement, remission, quit-claim, warrant, fine, & agreement the same Humphrey & Robert have given to the foresaid Earl one hundred & eighty pounds sterling.

The fifteenth proclamation on the second day of July in the same term;

The sixteenth proclamation on the fourth day of July in the same term.
