SUMMARY: The document below is the fine of 20 January 1584 by which clear title to Colne Park passed from Oxford to Roger Harlakenden (b. about 1539, d.1603) for £800. Earls Colne, including the park, had been among Oxford's manors granted by the Queen to Leicester on 22 October 1563 for the term of Oxford's minority. In the 26th year of the reign of Queen Elizabeth [=1583/4], Oxford acknowledged two recognizances, each in the amount of £1000, to Roger Harlakenden, presumably in connection with the sale of Colne Park (see TNA 30/34/14, Item 3). For the indenture dated 17 November 1583 by which Oxford sold Colne Park to Roger Harlakenden for £2000, see ERO D/DPr 181, available on microfilm under catalogue reference Ph 4/152/5. Roger Harlakenden also states in an undated memorandum to Lord Burghley written circa 1587 that he paid Oxford £2000 for Colne Park (see BL Lansdowne 77/8, f. 198). In the fine below, the sale price is said to have been only £800. The stated consideration in the fictitious lawsuits known as fines is often unreliable.

This is the final agreement made in the court of the Lady Queen at Westminster on the octave of Saint Hilary in the year of the reigns of Elizabeth, by the grace of God Queen of England, France, & Ireland, Defender of the Faith, etc. from the Conquest the twenty-sixth [=20 January 1584], before Edmund Anderson, Thomas Meade, Francis Wyndham & William Periam, justices, & others faithful to the Lady Queen then there present, between Roger Harlakenden, esquire, querent, and Edward, Earl of Oxford, deforciant, of the park of Colne with the appurtenances and of five messuages, five tofts, five gardens, five orchards, three hundred acres of arable land, two hundred acres of meadow, seven hundred acres of pasture, two hundred acres of wood, & forty shillings' rent with the appurtenances in Earls Colne, Halstead & Markshall;

Whereof a plea of covenant was summoned between them in the same court, namely that the foresaid Earl acknowledged the foresaid park & tenements with the appurtenances to be the right of himself, Roger, as those which the same Roger has of the gift of the foresaid Earl, and he has remised & quit-claimed them from himself and his heirs to the foresaid Roger and his heirs forever;

And besides the same Earl has granted for himself & his heirs that they will warrant to the foresaid Roger & his heirs the foresaid park & tenements with the appurtenances against the foresaid Earl & his heirs, and against the heirs of John, late Earl of Oxford, deceased, father of the same Earl, forever;

And for this acknowledgement, remission, quit-claim, warrant, fine & agreement the same Roger has given to the foresaid Earl eight hundred pounds sterling.
