SUMMARY: The document below is the fine in the Court of Common Pleas dated 20 January 1584 by which clear title to the manor of Bretts passed from Sir Thomas Heneage (b. in or before 1532, d. 1595) and his wife, Anne (c.1530-1593), to Roger Townshend (c.1544-1590) for £480. Two months later, on 7 March 1584, Townshend sold the manor of Bretts to Oxford (see HL/PO/PB/1/1609/7J1n33). It seems likely that the sale of Bretts was part of an exchange of properties between Oxford and Townshend since by a fine of 6 May 1584 Townshend purchased the manors of Wivenhoe, Battleswick and Great Bentley from Oxford for £2513 (see TNA CP 25/2/132/1693/26 ELIZIEASTER, Item 51).

This is the final agreement made in the court of the Lady Queen at Westminster on the octave of Saint Hilary in the year of the reigns of Elizabeth, by the grace of God Queen of England, France, & Ireland, Defender of the Faith, etc. from the Conquest the twenty-sixth [=20 January 1584], before Edmund Anderson, Thomas Meade, Francis Wyndham & William Periam, justices, & others faithful to the Lady Queen then there present, between Roger Townshend, esquire, querent, and Thomas Heneage, knight, & Anne, his wife, deforciants, of the manor of Bretts with the appurtenances and of six messuages, six tofts, six gardens, sixty acres of arable land, a hundred acres of meadow, a hundred acres of pasture, a hundred acres of marsh & forty shillings' rent with the appurtenances in West Ham & Flatwick;

Whereof a plea of covenant was summoned between them in the same court, namely that the foresaid Thomas & Anne acknowledged the foresaid manor & tenements with the appurtenances to be the right of himself, Roger, as those which the same Roger has of the gift of the foresaid Thomas & Anne, and they have remised & quit-claimed them from themselves, Thomas & Anne, & their heirs to the foresaid Roger and his heirs forever;

And besides the same Thomas & Anne have granted for themselves & the heirs of the same Thomas that they will warrant to the foresaid Roger & his heirs the foresaid manor & tenements with the appurtenances against the foresaid Thomas & Anne & the heirs of the same Thomas, and against Michael Heneage, esquire, and his heirs, William Poyntz, gentleman, & his heirs, and against Miles Grey & his heirs forever;

And for this acknowledgement, remission, quit-claim, warrant, fine & agreement the same Roger has given to the foresaid Thomas & Anne four hundred & eighty pounds sterling.
