SUMMARY: The document below is the Prerogative Court of Canterbury copy of the will, dated 13 February 1587 and proved 31 May 1587, of Hugh Newport, gentleman, of Corsham, Wiltshire, brother of Sir Richard Newport (d. 12 September 1570), owner of a copy of Hall's *Chronicle* containing annotations thought to have been made by Shakespeare. The volume was Loan 61 in the British Library until 2007, was subsequently on loan to Lancaster University Library until 2010, and is now in the hands of a trustee, Lady Hesketh. According to the Wikipedia entry for Sir Richard Newport, the annotated Hall's *Chronicle* is now at Eton College, Windsor. See:

According to the PCC copy, the testator made his will on 13 February 1587, which would usually be taken as 13 February 1588 (New Style). However according to the probatum clause, the will was proved on 31 May 1587. Unless the probatum clause is in error, the will should therefore be dated 13 February 1587 (New Style).

He is not mentioned in his father's will dated 24 July 1548, and was likely born after that date. See the will of Thomas Newport, dated 24 July 1548 and proved 11 June 1551, TNA PROB 11/34/176.

The testator's mother, Anne Corbet, was the daughter of Sir Robert Corbet (c.1477 – 11 April 1513) by Elizabeth Vernon, the daughter of Sir Henry Vernon (c.1441 – 13 April 1515) of Haddon, Derbyshire. In the name of God, Amen. February 13th Anno 1587. I, Hugh Newport of the parish of Corsham in the diocese of Sarum and county of Wiltshire, gentleman, sick in body but of good and perfect memory, the Lord be praised, do make my last will and testament in manner and form as followeth:

First I bequeath or rather render again my soul unto God Almighty, my heavenly Father, and to his only Son, Our Lord Christ Jesus, my only Saviour and Redeemer, by the merits of whose death and passion I surely trust to be saved and to enjoy his glorious kingdom among the chosen children of God, our heavenly Father;

And I bequeath my body to be buried in the parish church of Corsham aforesaid;

[=The above-written testament was proved at London before the worshipful Master William Drury, Doctor of the Laws, Commissary of the Prerogative Court of Canterbury etc., on the last day of the month of May in the year of the Lord the thousand five hundred fifty-seventh by the oath of Thomas Barker, notary public, proctor of Jane, relict and executrix named in the same testament, to whom administration was granted etc. sworn on the Holy Gospels to well and faithfully administer etc.]
