

SUMMARY: The document below is a list compiled 25 March 1579 of those, including Oxford, who had not paid all or part of the sums subscribed by them for the third Frobisher voyage to the Canadian Arctic. The heading states that the venturers included in the list had not already paid Michael Lok, the former treasurer of the expedition, and were therefore to pay the sums owed to the new treasurer, Thomas Allen. According to a letter written by Lok to Sir Francis Walsingham on 15 December 1578:

And since that Mr Allen was appointed to be treasurer, I have not received one penny of money of any of the venturers but only £28 of my Lady Martin, whereof I paid out £20 unto Denham for his journey into the North, and the rest with a more sum is paid out for divers petty parcels which grow daily upon the works of Dartford and amongst men for their service.
