Honour or manor of Whitchurch and manor of Aston Sandford with the appurtenances in the county aforesaid, parcel of the foresaid lands.

Account of Richard Wood, bailiff there for the foresaid time.

Arrearages: The same accountant is charged with **£55 10s 3d** of arrearages in the last account of the next preceding year, as appears there in the foot. Total: **£55 10s 3d**.

Earl or to be retained in his own hands on any his account of the foresaid premises, with a clause of distraint as above, as by the foresaid deed in the foresaid inquisition specified more fully is clear & appears.
