Honour or manor of Castle Camps in the county of Cambridge, parcel of the foresaid lands.

Account of Henry Golding, esquire, bailiff there for the foresaid time.

Arrearages: The same accountant is charged with **£61 3s 6d** of arrearages of the last account of the next preceding year, as appears there in the foot. Sum: **£61 3s 6d**.

Issues of the lands by the inquisition

And received of **£42 17s** resulting or arising from the issues of the foresaid honour or manor of Castle Camps in the foresaid county of Cambridge of the yearly value of **£42 17s**, held together with the manors of Roseworthy, Tregenna & others in the county of Cornwall & with others in divers other counties but of whom (s. & pl.) is unknown, of which certain honour or manor & the rest of the premises with all & singular their appurtenances the foresaid John, late Earl of Oxenford, before his death was seised among other honours, castles, lordships, manors, lands, tenements & the rest of the hereditaments of the same late Earl in his demesne as of fee, and thus being seised a certain fine was levied, as before in the account of the honour, castle, or manor of Hedingham in the county of Essex more fully appears.

And the foresaid late Earl by certain indentures recited above in the foresaid account among other things granted, promised, & fully agreed for himself & his heirs to & with the forenamed Duke of Norfolk, Robert, Lord Dudley, & Thomas Golding, their heirs & executors, that he, the late Earl, his heirs & assigns, from the time of the making of the same indenture would stand & be seised of the foresaid honour or manor among others to the uses, intentions, pledges, & trusts below declared, viz., to the use of himself, the late Earl, for term of his life without impeachment of any waste, and after his decease to the use of the forenamed Edward, now Earl of Oxenford, & of the heirs males of his body lawfully begotten, and for lack of such issue then to the behoof & use of the heirs males of the body of the said late Earl lawfully begotten, and for lack of such issue then to the behoof of Aubrey de Vere, brother of the said late Earl, for term of the life of himself, Aubrey, and after his decease then to the behoof & uses as in the foresaid account more fully appears.

And the foresaid late Earl thus thereof being seised, died thereof seised, except that the same late Earl by a certain deed of his sealed by his seal at arms & subscribed by his own hand bearing date the 20th day of the month of September in the first year [=20 September 1559] of the reign of the Lady Elizabeth now Queen for & in consideration of good, true, & faithful service to him by **John Lovell** previously done & thereafter to be done gave & granted to the same John Lovell a certain annuity or yearly rent of **£10** sterling yearly issuing & to issue of his manor of Castle Camps in the county of Cambridge and of all other his lands, tenements, & possessions whatsoever within the

foresaid manor, to have, levy, enjoy, & yearly perceive the foresaid annuity or yearly rent of £10 to the forenamed John Lovell & his assigns at [sic] the feast of the Annunciation of Blessed Mary the Virgin then last elapsed to the term & for the term of his natural life, to be paid yearly at the feasts of the Nativity of Saint John the Baptist, Saint Michael the Archangel, the Nativity of the Lord, & the Annunciation of Blessed Mary the Virgin by equal portions, and the foresaid late Earl by his foresaid deed granted that for non-payment of the foresaid annuity or yearly rent of £10 it would be well allowed to the forenamed John Lovell & his assigns to distrain in the foresaid manor of Castle Camps & the rest of the premises, as by the same deed in the foresaid inquisition specified more fully appears.

And the foresaid late Earl by a certain other deed of his above specified at large in the account of Robert Read, bailiff of Bumpstead Countesmead & others in the county of Essex, parcel of the foresaid inheritance, gave, granted, & ordained **John Turner**, gentleman, to be high steward, so of all & singular courts & leets as there similarly specified, to have by year **£6 13s 4d** viz., **£4** issuing of the foresaid manors of Castle Camps in the county of Cambridge & Helions Bumpstead in the county of Essex, & the remainder of **53s 4d** out of the manors of Old Hall & le Commandry in the county of Suffolk, as by the foresaid deed in the foresaid account is declared at large.

And the foresaid late Earl by a certain other deed of his sealed by his seal at arms & subscribed by his own hand bearing date the 21st day of August in the first & second years [=21 August 1554] of the reigns of the late King & Queen Philip & Mary, so for good & faithful service by his beloved servant **Henry Golding** many ways done as for divers other causes & considerations himself moving, gave & granted to the same Henry Golding the office of keeper & constable of his castle of Camps and also the office of keeper of his park of Camps, and also the office of bailiff of his lordship or manor of Camps in the county of Cambridge, to have & exercise all & singular the forenamed offices & any of them to the forenamed Henry Golding & his assigns during the natural life of the same Henry by himself or by his sufficient deputy or his deputies, and the foresaid late Earl by the foresaid deed granted to the foresaid Henry Golding for the exercise & occupation of the foresaid office[s] the wages & fees below written viz., for the exercise of the foresaid office of keeper & constable of the castle one annuity of **40s** sterling by year, and for the exercise & occupation of the office of keeper of the foresaid park one yearly rent of **£4 11s 3d** by year, and also for the exercise & occupation of the office of bailiff of the lordship or manor of Camps aforesaid one annuity of **60s 10d** sterling, with all other profits, advantages, commodities, payments, & emoluments whatsoever to the same offices & to any of them previously or at any time past by whatever right appertaining or belonging, and in so ample manner & form as Robert Tyrrell or any other or any others formerly exercising or occupying the same offices aforesaid or any of them has had, perceived, or enjoyed, [+or] have had, perceived, or enjoyed, to have & yearly perceive, receive, & enjoy all the foresaid wages, annuities, or yearly rents aforesaid to the forenamed Henry Golding & his assigns to be paid yearly during his whole natural life by his own hands or by the hands of the receivers, bailiffs, & other occupants of the lordship or manor of Camps aforesaid at the feasts & terms there usual by equal portions, and moreover the foresaid late Earl by the foresaid deed granted

for non-payment of the foresaid annuity or yearly rent that it would be well allowed to the forenamed Henry Golding & his assigns to enter & distrain in the foresaid castle, lordships, manors, & park aforesaid & any parcel thereof, as by the same deed in the foresaid inquisition specified more fully is clear & appears.

And it remains in the hands of the Lady Queen as is specified above in the account of the foresaid honour, castle, & manor of Hedingham in the foresaid county of Essex, and in the total as above is valued by year by the foresaid inquisition, to be paid at the feasts of the Annunciation of Blessed Mary the Virgin & Saint Michael the Archangel equally, viz., for two such feasts falling within the time of this account. And there remains: Sum: **£42 17s.**

Increase of rents by the survey of the feodary

And received of **£9 12s 1d** resulting or arising from the increase of rents of the foresaid manor with the appurtenances at £9 12s 1d by year thus assessed by the survey thereof made by William Bugby, gentleman, feodary, surveyor, & receiver of all the lands of the wards of the Lady Queen in the county of Cambridge, & remaining of record in the Court of Wards & Liveries of the same Lady Queen, more than by the foresaid inquisition is found, to be paid at the foresaid feasts equally, viz., for two such feasts falling within the time of this account.
